This policy and procedure applies to Pediatrics patients treated at INODAYA Hospital - Kakinada


3.0 Definition:


- a) **Pediatric Patients** - Patients less than or equal to 18 years old including premature, newborns, neonates, infants, toddlers, children and adolescents.
- b) **Premature Baby** - A baby born at or before 37th week of gestation period.
- c) **Neonate** - A newborn baby up to first four weeks of life.
- d) **Infant** - A child under 1 year of age and/or who is unable to walk unassisted.
- e) **Adolescent** - A child with time period between beginning of puberty and adulthood.
- f) **Competency** - It is the process of evaluating the performance of employees during a defined period of time with the aim of ascertaining their suitability for the job, potential for growth as well as determining training needs.
